



## What is SUN Bucks EBT?

SUN Bucks benefit is a one-time payment of **\$120** per eligible child during summer break for groceries. Families can use it along with benefits like SNAP/WIC and other summer meal programs. Receiving SUN Bucks will not affect families' immigration status.

Eligible students will receive a DSHS approval notice and a SUN Bucks EBT card via U.S. Mail. DSHS plans to issue benefits July through the end of August 2025. Get more information here: [www.dshs.wa.gov/SUNBucks](http://www.dshs.wa.gov/SUNBucks)

## Who is Eligible?

- Students who submit a qualifying [CNEEB Application](#).
- Students who are Directly Certified already participating in SNAP/TANF/Medicaid programs, etc..
- Students that are Determined eligible through [SUN Bucks \(DSHS\) Application](#).

## Do you need to take action?

Many students will get SUN Bucks automatically, however, some families may need to apply. You will need to apply if you are not automatically qualified and have not yet submitted a CNEEB Application.

Apply to receive benefits as soon as possible. You may fill out & turn in the [CNEEB Application](#) to your school main office or submit [online via Skyward Family Access](#) **before May 15, 2025**. ASD will accept CNEEB Applications until **June 18, 2025**.

Students who do not qualify automatically and did not submit a CNEEB Application **before June 18, 2025** can apply directly via [SUN Bucks \(DSHS\) Application](#) available online in English & Spanish. DSHS Applications will be accepted through **Aug. 31, 2025**.

## Important Reminders:

If you move during the summer, please update your address directly with DSHS SUN Bucks contact center. ASD does not distribute or manage SUN Buck EBT cards.

*In preparation for 2025 SUNBucks, please check/update as needed the mailing address listed for Household/Family 1 in Skyward Family Access. The address on file will be used to deliver SUNBucks EBT Card.*



## Child Nutrition Eligibility & Education Benefit Application (CNEEB)

The Auburn School District has been approved to participate in the Federal Community Eligibility Provision (CEP) that provides school breakfast and lunch at no charge for all enrolled ASD students regardless of family household income. We are so excited to offer healthy, nutritious meals to all ASD students.

Schools participating in Community Eligibility Provision (CEP) use the CNEEB Application to gather important income data to qualify for school funding. The CNEEB Application replaces the previous Family Income Survey (FIS) form.

The [CNEEB Application](#) helps to fund school programs, may waive school fees & qualify your family for other community programs.

### Funds tied to the CNEEB include:

- Before and After school academic and enrichment programs
- Learning Assistance Program (LAP)
- Resources for classrooms and teachers
- Additional School Support Staffing



### Completing the CNEEB could qualify students for programs or waive/reduce fees:

- SUN Bucks EBT eligibility
- Scholarships eligibility
- ASB/Athletic card
- Field Trips/ Extra Curricular Activities



### **EVERY ELIGIBLE CNEEB COUNTS!**

Every eligible CNEEB that is not submitted means lost resources for our schools. Submit your completed [CNEEB Application](#) as soon as possible to help make sure it counts toward potential new funding for our school this year.
