

Nurse Notice

Please keep your child home from school if he/she has:

- A fever over 100 degrees—students must be fever free for 24 hours before returning.
- Vomiting— Child should be kept home until they can keep food and water down and has not vomited in a 24 hour period.
- Diarrhea— Students should stay home until a 24 hour period has passed since the last episode.
- Open or oozing sores— Unless properly covered with a bandage that will not leak at school.
- Cough

 Please keep home if they have a course, deep, or productive cough.
- Runny Nose and Sneezing: Do not send to school with nasal discharge that is yellow, green, or brown.

PLEASE CALL THE SCHOOL IF YOUR CHILD WILL BE ABSENT FOR ANY REASON.

State law (RCW 28A.225.020) requires that, if your student has two unexcused absences in one month, we schedule a conference with you and your student to identify the barriers and supports available to ensure regular attendance. The district is obligated to develop a plan that may require an assessment to determine how to best meet the needs of your student and reduce absenteeism.

In elementary school after five excused absences in any month, or ten or more excused absences in the school year, the school district is required to contact you to schedule a conference at a mutually agreeable, reasonable time with at least one district employee, to identify the barriers and supports available to you and your student. A conference is not required if your student has provided a doctor's note, or pre-arranged the absence in writing, and the parent, student and school have made plan so your student does not fall behind academically. If your student has an Individualized Education Plan or a 504 Plan the team that created the plan needs to reconvene.

State law RCW 28A.225.010, states that if your student has seven unexcused absences in any month or ten unexcused absences within the school year, we are required to file a petition with the Juvenile court, alleging a violation of RCW 28A.225.010, the mandatory attendance laws. If your student continues to be truant you may need to go to court.
