STUDENT AND STAFF RECOGNITION

1. Recognition of Student

The Auburn School District Board of Directors will recognize Kylie Niles, a fifth grade student at Gildo Rey Elementary School, for being an outstanding student.

Kylie Niles is an outstanding student at Gildo Rey Elementary. She applies her best work in everything she does and excels in all academic classes. Kylie has passed the MSP assessments the past two years in all subject areas. She understands that hard work pays off.

Kylie is actively involved in the school community. She is a leader who was nominated by her class to be the ASB representative last year and she is running for ASB school secretary this year. Kylie is a dedicated peer model for the kindergarten students as a kindergarten tutor. Kylie also participates in the annual all-school play. Her teachers say, "Kylie is an outstanding student who always gets her work done and always follows the school's code of conduct. She is always very polite and is a great friend to others."

Kylie enjoys roller-skating and playing tennis with her dad at Game Farm Park. She just came back from a trip to Disneyland with her grandparents. It was her first time in an airplane and her first trip to Disneyland!

Kylie plans on joining choir and orchestra in middle school and wants to learn how to play the viola.

2. Recognition of Staff

The Auburn School District Board of Directors will recognize Ben Talbert, Rainier Middle School Principal, for his outstanding service.

Ben Talbert's road to success has been filled with defining moments. Moments like dropping out of school at 15; running his family business; earning a GED; proselytizing in Rome; writing for the <u>Seattle Times</u>; completing a masters in teaching; changing careers; and now leading students and staff as Rainier Middle School's principal.

One of Ben's more recent defining moments occurred four years ago after experiencing a health scare. "I had to make changes to stay alive," remarks Ben. "I'm living a healthier lifestyle today." Down 110 pounds, Ben fuels his body with whole foods and cuts calories through routine exercise. Whether going to school or church, Ben pedals. "When the district reduced transportation routes, I decided to start riding to and from school instead of driving as a way of setting an example for our students. Cycling is now my primary mode of transportation," says Ben. And that's not all. Ben wakes at 5 a.m. to run, lift or swim. Combined with a diet of fruits, vegetables, and lean protein, Ben is no longer diabetic and is off the majority of his medications. He recently completed the Seattle to Portland bike ride, his first half-marathon and

sprint triathlon, and has his eyes set on more endurance events—even an Ironman triathlon.

Ben hopes to model healthy choices to his family, students, and staff. "Healthier living directly impacts student learning," says Ben. "My primary focus is to increase student achievement and provide opportunities for all students to achieve more tomorrow than they are today."

Rainier Middle School commits to offer a world-class education. Currently, Rainier offers algebra and geometry courses at the highest levels; six levels of tiered instruction, three types of interventions; a new biology course; award-winning music programs; and innovative after-school programming like robotics, Minecraft, service learning, and more. "Our staff is focused on this work," says Ben, "and commits to meeting the needs of each individual learner."

One of Ben's proudest accomplishments is witnessing the daily learning of Rainier students. "We have a great staff," says Ben, "who is committed to helping define the learning moments of all students. Sometimes it's really hard, but it's also very rewarding."

Ben is often spotted cycling throughout town with his family including his wife and four children.

3. Gold Star

The Auburn School District Board of Directors will present the Gold Star Volunteer Award to Dan Kempi in recognition of his volunteer support to Auburn School District.

Dan Kempi retired as head custodian from Evergreen Heights Elementary two years ago but accepted a new role of 'volunteer extraordinaire' during the entire 2011-12 school year. From encouraging healthy eating to tutoring students, Mr. Kempi volunteered at Evergreen Heights every school day for four hours.

According to Principal Anne Gayman, "Dan is an important member of our school community. After he retired, I asked him if he was interested in continuing to help out with various activities and he graciously accepted."

Over the course of the school year, Dan spearheaded the following activities:

- Managed the Green Schools program, a recycling and composting initiative he launched as an employee. The program has saved thousands of dollars a month in waste removal fees.
- Encouraged students to eat healthy meals during breakfast and lunch.
- Read to students who required reading intervention services.
- Facilitated outdoor activities to increase students' fitness levels.

Dan feels fortunate to have had the time and ability to continue interacting with staff and students in retirement. "Retiring is a withdrawal from people I've been with for many years, so returning was a much more subtle and easier transition into retirement," says Dan.

The Evergreen Heights community will always remember Mr. Kempi as 'Coach K,' a nickname he earned as a Timberwolves' assistant basketball coach. No one will forget his yodeling skills either. Last year Mr. Kempi wrote and yodeled a song titled, "We love our school," at the annual Evergreen Heights PTA fundraiser. "It was a blast," smiles Dan.

Currently, Mr. Kempi is a substitute custodian at Washington Elementary School and plans to become an Arizona snowbird. He also hopes to compose another yodel or two.

HIGH SCHOOL GRADUATION REQUIREMENTS (DRAFT 8/13/12)

A. The board shall will award a regular high school diploma to every student enrolled in the district who meets the requirements of graduation established by the district. Only one diploma shall will be awarded with no distinctions being made between the various programs of instruction which may have been pursued.

The board shall will establish graduation requirements which, as a minimum, satisfy those established by the State Board of Education:

English (reading, writing and communications)	4 credits
Mathematics	3 credits
Science (physical, life and earth; one laboratory credit)	2 credits
Social Studies (civics, history and geography)	2.5 credits
Health and Fitness	2 credits
Arts	1 credit
Occupational Education	1 credit
Electives	7 credits

A credit is defined as 150 hours of planned instructional activities excluding passing time. The board shall will approve additional graduation requirements as recommended by the superintendent.

In addition to the minimum credit requirements, to earn a diploma each student must:

- 1. Pass the reading and writing portions of the statewide assessment;
- 2. Complete a High School and Beyond Plan: Within the first year of high school enrollment, each student shall will develop a plan for satisfying the state and district's high school graduation requirements and for their first year after high school completion. The plan should be developed in collaboration with the student, parent and district staff. The plan should include how the student will satisfy the district's academic credit requirements, preparation for successfully completing the Washington Assessment of Student Learning statewide assessment, a description of the student's culminating project and the student's goals for the year following graduation. Each student plan should be reviewed annually at the beginning of the school year to assess student progress, to adjust the plan, and to advise the student on steps necessary for successful completion of the plan;
- 3. Complete a Culminating Project: During the course of their high school career, each student shall complete a culminating project. The project shall will demonstrate the student's ability to think analytically, logically and creatively, and to integrate experience and knowledge to form reasoned judgments and solve problems. The project will also have a connection to the world of work in that it will demonstrate that the student understands the importance of work and how performance, effort, and decisions directly affect future career and educational opportunities;
- 4. Complete math requirements: Students in the class of 2009-12 who fail to successfully pass the mathematics portion of the statewide assessment or an appropriate alternative, must earn two mathematics credits or career and technical education equivalent mathematics credits after 10th grade. Credits earned must meet high school standards. Students in the Cclasses of 2013 and beyond 2014 must pass the mathematics portion of the statewide assessment, an alternative assessment, or an end of course examination; and one end of course assessment (either Algebra 1 or Geometry or their integrated math equivalents) or state-approved alternative. Students in the classes of 2015 and beyond must pass two end of course assessments (Algebra I and Geometry or their integrated math equivalents) or state-approved alternative.
- 5. Complete science requirements: Students in the class of 2013 2015 and beyond must pass the science statewide biology end-of-course assessment or an appropriate state-approved alternative.
- B. Students in the class of 2013 and beyond must complete mathematics courses in one of the following progressive sequences.
 - 1. Algebra I, Geometry, and Algebra II; or
 - 2. Integrated Mathematics I, Integrated Mathematics II, and Integrated Mathematics III; or

3. Any combination of (a) and (b) in progressive sequence.

In lieu of a third credit of mathematics, students may choose an alternative mathematics course if the parent/guardian agrees that the third credit mathematics elective is supportive of the student's education and career goals. Before approval of the elective third mathematics credit, a meeting will be held with the student, the parent/guardian, and the school staff to discuss the student's High School and Beyond Plan and the mathematics requirements for post-secondary and career choices.

The district will obtain a signed consent from the parent for the student to enroll in the alternative third credit of mathematics. The consent form will confirm the meeting, that the parent understands the impact of the selection on the student's educational and employment options, and that the alternative is most appropriate for the needs of the student.

Students may also satisfy the mathematics requirements by earning equivalency based credit in career and technical education mathematics courses. Those credits must be recorded using the equivalent academic high school department designation.

C. A student will receive a certificate of academic achievement only if they earn the appropriate number of credits required by the district, complete a culminating project, complete the high school and beyond plan; and meet the reading, writing and math standards on the high school statewide assessment or an appropriate alternative assessment.

Students qualifying for special education services will earn a certificate of individual achievement as determined by their individual education plan.

- D. High school credit will be awarded for successful completion of a specified unit of study. In this district, successful completion of a specified unit of study means:
 - 1. Earning a passing grade according to the district's grading policy; and/or
 - 2. Demonstrating proficiency/mastery of content standards as determined by the district; and/or
 - 3. Successfully completing an established number of hours of planned instructional activities to be determined by the district.

The district will establish a process for determining proficiency/mastery for creditbearing course of study.

- **DE**. The superintendent shall will develop procedures for implementing this policy which include:
 - 1. Establishment of the process and assessment criteria for the high school culminating project requirements, and determination of the education plan process for identifying competencies.
 - 2. Establishing the process for completion of the High School and Beyond Plan.

- 3. Recommending course and credit requirements which satisfy the State Board of Education requirements and recognize the expectations of the citizens of the district.
- 4. Determining which courses satisfy particular subject area requirements and whether a particular course may satisfy more than one subject area requirement, including a process for determining the credits, the district will recognize for courses taken through another program recognized by the state (e.g. another public school district or an approved private school) or those courses taken by students moving into the state from another state or country. Decisions regarding the recognition of credits earned before enrolling in the district will be based on the professional judgment of the high school principal or designee based on an evaluation of the student's former program and demonstrated knowledge and skills in the discipline for which credit is sought. The decision of the principal may be appealed to the superintendent within fifteen school days.
- 5. Making graduation requirements available in writing to students, parents, and members of the public.
- 6. Providing for a waiver of graduation requirements for an individual student when permitted. All state graduation requirements must be satisfied unless a waiver is permitted by law;
- 7. Granting credit for learning experiences conducted away from school, including National Guard high school career training.
- 8. Granting credit for correspondence, vocational-technical institutes ,and/or college courses for college or university course work the district has agreed to accept for high school credit. State law requires that the district award one high school credit for every five quarter hour credit or three semester hour credit successfully earned through a college or university, except for community college high school completion programs where the district awards the diploma. Teenth and eleventh grade students and their parents shall will be notified annually of the Running Start Program.
- 9. Granting credit for work experience.
- 10. Granting credit based upon competence testing in lieu of enrollment.
- 11. Granting credit for high school courses completed before a student attended high school, to the extent that the course work exceeded the requirements for seventh or eighth grade.
- 12. Counseling of students to know what is expected of them for completion of their schooling in order to graduate.
- 13. Preparing a list of all graduating students for the information of the board and release to the public.
- 14. Preparing suitable diplomas and final transcripts for graduating seniors.
- 15. Planning and executing graduation ceremonies.

16. Developing student learning plans for students who are not successful on one or more components of the statewide assessment.

In the event minimum test requirements are adopted by the board, a student who possesses a disability shall will satisfy those competency requirements which are incorporated into the Individualized Education Program (IEP). Satisfactory completion of the objectives incorporated into the IEP shall will serve as the basis for determining completion of a course.

A student shall will be issued a diploma after completing the district's requirements for graduation. In lieu of the certificate of academic achievement, special education students may earn a certificate of individual achievement. A student shall will also be advised that he/she may receive a final transcript.

However, a student's diploma or transcript may be withheld until the student pays for any school property that has been lost or willfully damaged. Upon payment for damages or the equivalency through voluntary work, the diploma or transcript will be released. When the damages or fines do not exceed \$100, the student or his/her parents shall will have the right to an appeal using the same process as used for short-term suspension as defined in Policy 3241, Classroom Management, Corrective Actions or Punishments. When damages are in excess of \$100, the appeal process for long term suspension as defined in Policy 3241, Classroom Management, Corrective Actions or Punishments shallwill apply.

Graduation requirements in effect when a student first enrolls in high school shall will be in effect until that student graduates unless such period is in excess of ten years.

In the event that other forms of corrective actions are imposed for violations of school rules, the student may be denied participation in graduation ceremonies. Such exclusion shall be regarded as a school suspension. In such instances, the diploma will be granted.

AGREEMENT Between AUBURN SCHOOL DISTRICT #408 And AUBURN PUBLIC SCHOOLS FOUNDATION

This Agreement is entered into by and between the Auburn School District #408, a Washington municipal corporation ("District") and the Auburn Public Schools Foundation, a Washington nonprofit corporation ("Foundation").

WHEREAS, the District, pursuant to RCW 28A.320.030 may receive such gifts, grants, conveyances, devises and bequests of personal and real property, in trust or otherwise, for the use or benefit of the District or its students and may enter into contracts and adopt regulations to provide for the receipt and expenditure of the foregoing; and

WHEREAS, the Foundation has been created for the express purpose of securing and distributing contributions for the educational benefit of the students of the District; and

WHEREAS, the District desires to enter into an Agreement with the Foundation for the securing and distribution of contributions for the benefit of the District;

NOW, THEREFORE, the parties agree as follows:

1. The Foundation shall:

- A. Expend its best efforts to seek to accrue gifts, grants, conveyances, devises, and bequest of money and real and personal property for the benefit of the District. For this purpose, the Foundation shall design and implement programs and procedures in coordination with the District to solicit, receive and convey such money and property to the District.
- B. Comply with all applicable federal and state laws. For this purpose, the Foundation shall establish rules and procedures for the management of all affairs of the Foundation in accordance with the requirements for tax exempt entities under federal law.
- C. Confirm annually to the District that it has fully complied with its obligation to expend its best efforts to seek to accrue gifts, grants, conveyances, devises, and bequest of money and real and personal property for the benefit of the District. For this purpose, the Foundation will list its accomplishments for the preceding year and share with the District its revenue and expense statements for the preceding year and its end-of-year balance sheet.
- D. Permit the District to inspect and/or copy all Foundation books, accounts and records at all reasonable times in order to determine compliance with the commitments made in this Agreement.

- E. Create and maintain a District alumni database that may be used by the District. Coordinate with District alumni for reunions and alumni contacts.
- F. Comply with all District policies and procedures when using District resources and personnel.

2. The District shall:

- A. Provide the Foundation with the use of District resources and personnel as determined by the Superintendent that are in line with District policies and that do not conflict or interfere with District purposes. In the event that the use of resources or personnel will conflict with District policies or interfere with District purposes, the District shall notify the Foundation.
- B. Maintain an accounting of the use of District resources or personnel used by the Foundation and the value thereof. District resources include but are not limited to: computer and internet access; Foundation specific phone number; website linkages; mailing address; and use of District mailings and facilities that do not impose an additional cost to the District.
- C. Use contributions in accordance with any restrictions imposed by the Foundation once accepted by the District. It is understood that the purpose of the contributions received from the Foundation are neither to replace the District's general operating funds nor to supplant funding derived from regular funding sources. Contributions from the Foundation are not intended to be considered a regular revenue source for the operations of the District.

3. Mutual Responsibilities:

- A. Independent Capacity: At all times and for all purposes of this Agreement, each party shall act in an independent capacity and not as an agent or representative of the other party.
- B. No Indemnification: Each party shall be responsible for the actions and inactions of itself and its own officers, employees, and agents acting within the scope of their authority.
- C. No Assignment: This Agreement is not assignable be either party, in whole or in part.
- D. Governing Law and Disputes: This Agreement shall be governed by the laws of the State of Washington. Before instituting any legal action hereunder, a party, through its president, shall meet with the president of the other party and attempt in good faith to resolve the disagreement. Venue of any action hereunder shall be King County Superior Court.

- E. Entire Agreement: This constitutes the entire agreement of the parties, including all oral understandings, on the subject of their general and overall relationship. However, the parties may enter into other stand-alone agreements on specific subjects.
- F. Modification: No alteration or modification of any term of the Agreement shall be valid unless made in writing and signed by the parties.
- G. Termination: This Agreement shall be effective upon execution and shall continue until terminated. Either party may terminate this Agreement with 90 days written notice.

RESOLUTION NO. 1169 RESOLUTION IN OPPOSITION OF INITIATIVE 1240

WHEREAS, Initiative 1240 (authorizing the creation of a public charter school system) has been certified by the Secretary of State and will appear on the November statewide ballot; and

WHEREAS, The Initiative will not provide the necessary resources to support all students, undermining the Supreme Court's recent order in *McCleary v. State of Washington* to comply with the constitutional paramount duty to amply fund basic K-12 education so all students have the opportunity to succeed; and

WHEREAS, Implementation of the Initiative will create additional administrative functions and costs for the State Board of Education and OSPI, further draining millions of dollars from our already underfunded, existing public schools; and

WHEREAS, I-1240 will establish a separate and unequal school system, in violation of Washington's constitutional provision requiring a "general and uniform system of common schools" (Article IX), by exempting charter schools from most state laws and rules, while not providing the same flexibility to currently existing public schools; and

WHEREAS, I-1240 will undermine local control by allowing appointed charter boards and out-of-state charter management companies to operate charter schools with little-to-no accountability to Washington taxpayers; and

WHEREAS, The privately operated, but publicly funded, charter schools created under I-1240 will only serve a small part of Washington's student population, providing no guarantee that students who are struggling will have access to charter schools; and

WHEREAS, Research by Stanford University and others shows that, overall, charter schools do not perform better than traditional public schools and nearly 40 percent of them do worse; and

WHEREAS, Numerous innovative programs and schools, which are inclusive, equitable and accountable, have been created throughout the state under the currently authorized governance structure of locally elected school district boards of directors, proving a new system of charter schools in unnecessary; and

WHEREAS, Washington State voters have rejected three previous attempts to authorize charter schools;

NOW, THEREFORE, BE IT RESOLVED that the Auburn School District Board of Directors opposes Initiative 1240.
