# MINUTES OF THE REGULAR BOARD MEETING AUBURN SCHOOL DISTRICT NO. 408 February 10, 2014

The regular meeting of the board of directors was called to order by Ray Vefik, president, Monday, February 10, at 7 p.m., in the board room of the James P. Fugate Administration Building. All board members were present.

# Bond Sale Report

Michael Newman, deputy superintendent, provided an update to the board on the results of the bond sale which occurred on Wednesday, January 29, 2014. The district issued \$43,555,000 of Unlimited Tax General Obligation and Refunding Bonds, 2014 through a negotiated sale with D. A. Davidson serving as underwriter. Proceeds of the 2014 Bonds were used to provide \$45 million for the district's Capital Projects Fund for the Auburn High School Modernization and Reconstruction Project and to refinance the \$3.39 million remaining callable portion of the district's outstanding 2004 UTGO Bonds (Auburn Mountainview). Savings from refinancing the 2004 UTGO Bonds with this issue totaled nearly \$250,000 and are a direct benefit to all the taxpayers in the district.
