STUDENT AND STAFF RECOGNITION

1. Student Recognition





About the Program

What prompted your district to create this program?

The Auburn School Districts strategic plan is the blueprint for continuous improvement and a filter for how we allocate our time, talent and resources. Our primary goal in the plan is student achievement. One strategy of the plan was to implement professional learning communities (PLCs) giving teachers time to collaborate to improve practice. Another strategy was to build leadership capacity across the district. We recognized these two strategies were linked and that building teacher's instructional leadership would empower them to positively influence colleagues teaching practice through PLCs and, at the same time, distribute leadership across the district. While teachers lead from the classroom, principals are expected to be visionaries, managers, instructional leaders and evaluators. They are accountable for requirements imposed by the state and federal government and must be responsive to multiple stakeholders including central office, parents, staff and the community at large. Partnering with the Center for Strengthening the Teaching Profession (CSTP) from Tacoma, the district worked with CSTP staff to develop the Auburn Teacher Leadership Academy (ATLA). The program provides 75 hours of professional learning. Throughout the school year, academy participants are released for eight full-day academy sessions about once a month. Two teachers from each elementary and three teachers from each secondary school participate, resulting in a cohort of 50 teachers annually.

How did this program provide solutions?

There are five specific teacher leadership framework skills ATLA focuses on: working with adults; communication; collaboration; knowledge of content and pedagogy; and systems thinking. To ensure the professional learning experience for the cohort is targeted and meaningful, participants complete a comprehensive pre-assessment aligned to the leadership framework skills. The curriculum for the summer institute is custom designed based on the results of the self-assessments. Following each of the eight full-day sessions, participants complete a short survey and provide feedback. CSTP and Auburn leaders meet

monthly to review the surveys using the results and feedback to develop the content for the next session. At the conclusion of the year-long academy, participants complete the post-assessment. All academy participants (during the five years that the academy has been meeting) reported growth on all five of the specific leadership skills targeted through the academy, such as their ability to lead data-driven dialogue and developing norms of collaboration. This program provides exponential leadership growth to our teachers and academy participants have the skills to work with adult learners in PLCs to effectively lead conversations that increase student achievement. Standardized test scores in Auburn have been consistently rising and in most cases consistently exceed the state average in spite of increasing poverty and language diversity in our students.

What was your Board's leadership role in this program?

The Board supports the program as a critical tool for the successful implementation of PLCs. We have ensured that there are fiscal resources as well as the time for program leadership and participants to fully engage in ATLA. We have placed a heavy emphasis on ATLA because we believe that to make our student achievement goals, teachers need to be working together to study data and make changes in their teaching based on the results. We know that happens within PLCs and to ensure that meaningful, data-driven conversations occurred, teachers need the skills to be able to facilitate PLCs. This program provides those skills. We have led the efforts of ATLA through our commitment to the summer academy and release days. Another key component of the ATLA program is the availability of mini-grants to the participants. Each participant has the opportunity to apply for a \$500 mini-grants to pay teachers to bring back what they have learned in ATLA to their buildings. Participants choose the medium, whether it be writing about what they have learned, presenting to their building or departments, or leading a book study. Additionally, the board is visible during the program. The Board president speaks at the first session of each ATLA cohort to be visible to the teachers. ATLA participants have presented about their learning and the impact of the program at school board meetings. Each cohort has a graduation in June and board members hand out diplomas for those who complete the program.

Please describe the results of your program.

Student achievement in the Auburn School District continues on an upward trajectory. Our third through fifth grade math and English language arts SBA scores from 14-15 exceeded the state averages at all grade levels. The elementary poverty rate is 59% and 25% of elementary students are ELL. With these demographics, our students continue to outperform the state averages. With effective PLCs, all elementary schools have implemented walk to read to deliver personalized, targeted instruction. Our teachers are comfortable with courageous conversations about what strategies are working and what does not work. These conversations were rarely held prior to the implementation of PLCs using our teacher leaders. A lot of times teachers who are natural leaders are tapped to become administrators, even though their love is teaching. This program allows them to be leaders in the building and still teach. For the 15-16 school year, ATLA has been re-tooled to train our teachers to be leaders in instructional technology. One hundred teachers K-12 are participating this year, with an emphasis on best practices for instructional technology as we implement a \$22 million technology levy. They are focused on how to use technology for high-yield strategies for learning. The ATLA model provides the structure for teachers to increase their skills to increase student achievement.
