1. Resolution No. 1212—Authorization to Request to King County Elections Inclusion in the Voter's Pamphlet

Resolution No. 1212 provides the authorization to request to King County Elections to have Resolution No. 1211 Educational Program and Operations Replacement Levy measure included in the County's voter pamphlet for printing and distribution for the February 9, 2016, election.

RESOLUTION NO. 1212

A RESOLUTION of the Board of Directors of Auburn School District No. 408, King and Pierce Counties, Washington, authorizing the submission of a request to King County Elections for inclusion in the County's voter pamphlet for the February 9, 2016 election.

WHEREAS, the Board of Directors (the "Board") of Auburn School District No. 408, King and Pierce Counties, Washington (the "District") adopted Resolution No. 1211 on November 23, 2015 providing for the form of the ballot proposition and specifying certain other details concerning submission to the qualified electors of the District at a special election to be held on February 9, 2016, of a proposition for an educational program and operations in the principal amount of \$176,850,000 ("Proposition No. 1"); and

WHEREAS, the Board has determined that it would be in the best interest of the District to participate in the voters' pamphlet prepared by King County Elections;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF AUBURN SCHOOL DISTRICT NO. 408, KING AND PIERCE COUNTIES, WASHINGTON, as follows:

Section 1. Voters' Pamphlet. Pursuant to authority granted by RCW 29A.32.220, the Board of Directors hereby authorizes the District's participation in the local voters' pamphlet for the February 9, 2016 election and requests that King County Elections prepare and publish a voters' pamphlet for this proposition. The District understands and agrees that it will be required to pay its proportionate share of the expenses of the voters' pamphlet.

<u>Section 2</u>. <u>Confirmation of Resolution No. 1211</u>. Resolution No. 1211 is hereby ratified and confirmed. The Superintendent and/or Assistant Superintendent, Business and

Operations are hereby authorized and requested to deliver a certified copy of this resolution to King County Elections prior to 4:30 p.m. on Friday, December 11, 2015.

Section 3. Effective Date. This resolution shall become effective immediately upon its adoption.
