- Waiver transfers may only take place at the beginning of a grading period and must be renewed annually.
- **NOTE: Waiver requests shall be considered upon availability of space at the requested school. Requests received at the start of the school year may be held for up to 2 weeks after the first day of school to monitor enrollment capacity.**
